Lake weeds will be a major problem in our lake (and other lakes) for the foreseeable future. The DLPA will continue to investigate funding sources and alternative treatment methods to keep our lake from being choked by these nuisance exotic weeds.

## Watershed Committee Update

The Bio-Seawall Project, partially funded by LARE, has been postponed by the Directors because of monetary concerns. An expected grant from the Great Lakes Commission wasn't received thus greatly increasing the DLPA share for the project. The project may be completed in future years. The North & East shore Sediment Control Study, 90% funded by LARE, is nearly completed. The report will identify areas that contribute sediment to the lake and recommend methods to control the sediment erosion. JF New, project contractor, is working with the soil Conservation Service & County Highway Dept. on control methods. Larry Sheets & Jeff Kelsheimer have agreed to co-chair the Watershed Committee.
