Proposed Condo on Bethel College Property- Update

The decision by the Board of Zoning Appeals in September **not** to grant Uptown Partners (potential site developer) a zoning "exception" for the Bethel College property **was appealed**. (The "exception" would have allowed 12 Condos to be built on the property.) The Judge assigned to the appeal ruled in March that he was not going to make a decision on the appeal. Therefore, a completely new hearing (re-hearing, do-over) has been scheduled. The new hearing of the Board of Zoning Appeals is:

Tuesday April 8, 2008 at 11:30 am in the "old court" room in Warsaw
