## **Sediment Control Feasibility Study**

This summer JF New, of Walkerton, IN is beginning a LARE funded study of possible sediment control structures and methods along the north and east shores and Cable Run (inlet). ### Lake Weed Management Update

DLPA has been treating nuisance exotic lake weeds (Eurasian Watermilfoil) since 2006 with financial help and technical direction from the Indiana Department of Natural Resources <u>Lake & River Enhancement</u> program (LARE). The DLPA pays for biennial comprehensive aquatic vegetation management plans that can be found on our website. Eurasian Watermilfoil became a boating/swimming/fishing hindrance for the first time in 2004 & 2005 when approximately 150 acres of the lake had milfoil. A history of the chemical treatment is summarized in the table below:

2010 is critical to our milfoil management program because the DLPA, along with other Indiana Lakes, did <u>not</u> receive any LARE grant money **and** the acres of milfoil on the lake have been increasing rapidly the last few years. We don't want the milfoil to get out of control this year. We will chemically treat the Eurasian Watermilfoil areas in a fiscally conservative and strategic manner that attempts to limit this year's spread. Please donate to the tax deductible weed control fund on the membership form to help us control the spread of Eurasian Watermilfoil. The DLPA continues to explore non-chemical methods for lake weed control.
